



SIOR GROSS FEE INCOME REQUIREMENTS

To fulfill the Volume-of-Business requirement for the SIOR designation, applicants for membership must fulfill the Gross Fee Income (GFI) requirements as set by local chapters for individual markets by submitting an approved GFI Affidavit signed by the applicant's CFO or Managing Broker. If an applicant has neither, the affidavit may be completed by a CPA. The Affidavit forms are available from www.sior.com.

REQUIREMENTS

SIOR evaluates Volume-of-Business based on **Gross Fee Income** (GFI). GFI is defined as the amount that the **APPLICANT'S FIRM RECEIVES** (before internal splits with firm) that is directly attributable to the applicant.

Note: For applicants who work as part of a team, the GFI provided must reflect their internal team split for each transaction in which they were involved.

Applicants must submit the most recent trailing 48 months of GFI (the 'qualifying period'), with respect to their application date.

For example: For an application submitted in July 2026, the most recent 48-month period would be July 1, 2022, through June 30, 2026. GFI figures based on a calendar year breakdown can only be accepted in January.

Applicants must exceed the market GFI requirement that corresponds to each 12-month period within their qualifying period; the first month of each 12-month period shall determine the qualifying GFI amount.

To learn more about an applicant's GFI requirement, please refer to the chart below. Market requirements are defined by the county in which applicant's business address resides. If a market is not listed, the GFI defaults to \$300K.

MEMBER ASSOCIATES

- Meet 50% of the lower (either office or industrial) GFI requirement for any 12 consecutive months out of the most recent 18-month period.

INDUSTRIAL AND ADVISORY SPECIALISTS

- Meet or exceed the market GFI requirement corresponding to each 12-month period within qualifying period, for three (3) out of the last four (4) twelve-month periods. The first month of each 12-month period shall determine the qualifying GFI amount.
- At least 70% of the GFI requirement must be comprised of industrial and/or office transactions, for each qualifying year.

**OFFICE SPECIALISTS**

- Meet or exceed the market GFI requirement corresponding to each 12-month period within qualifying period, for three (3) out of the last four (4) twelve-month periods. The first month of each 12-month period shall determine the qualifying GFI amount.
- At least 70% of the GFI requirement must be comprised of industrial and/or office transactions, for each qualifying year

DUAL (INDUSTRIAL & OFFICE) SPECIALISTS

- Meet or exceed the combined total GFI requirement in each specialty type corresponding to each 12-month period within the qualifying period, for three(3) out of the last four (4) twelve-month periods. The first month of each 12-month period shall determine the qualifying GFI amount; **AND**
- At least 70% of the standard GFI requirement must be comprised of industrial transactions, for 3 of the last 4 twelve month periods; **AND**
- At least 70% of the standard GFI requirement must be comprised of office transactions, for 3 of the last 4 twelve month periods.

SALES MANAGEMENT SPECIALISTS

- GFI requirement is calculated by multiplying the average of the industrial and office GFI requirements by 7.5, for each year in the qualifying period. GFI must exceed that figure for three (3) out of the last four (4) 12-month periods. The first month of each 12-month period shall determine the qualifying GFI amount.
- GFI must be generated by top ten (10) industrial/office agents/brokers managed by the applicant.
- At least 70% of the GFI requirement must be comprised of industrial and/or office transactions.
